This time, the Research Council has received a total of 174 applications for the Academy Research Fellow posts. The success rate will be about 11-12 %.

Definition of the form of funding: Academy Research Fellowships are designed to offer researchers an opportunity to gain competence for high-level research posts (i.e. professorships) or other expert positions after the postdoctoral researcher stage. Very successful publishing and other scientific work after gaining the doctorate are requirements for appointment for an Academy Research Fellow post. Posts are filled for a period of five years in maximum. Those appointed to an Academy Research Fellow post may be granted funding for research costs and for setting up a research team, based on a separate application after the appointment.
